Position Overview – Payments Manager

We are actively recruiting for a Payments Manager to oversee the Payments Department for the organization. In this role, you will be responsible for the coaching and development of the Payment Specialists. This role requires an understanding of card portfolio management and controls, regulatory requirements of cards, lending, ACH, and drafts. This role also requires awareness of digital, core, and payment systems configuration, expense management, budgeting/forecasting, and vendor management.

- Must possess excellent communication skills, strong relationship development skills, and an ability to navigate through multiple areas of an organization.

- Ability to collect data, establish facts, and draw valid conclusions.

- Proficiency in math.

- Ability to write and respond to instructions and routine correspondence.
- Ability to organize information and communicate effectively both orally and in writing.
