# Virginia Credit Union League Announces Recipients of the Vizo Financial Empowerment Grants for 2024

**RICHMOND, Va.** — The Virginia Credit Union League, together with the Credit Unions Care Foundation of Virginia, is thrilled to announce the recipients of the 2024 Vizo Financial Empowerment Grants. Thirteen Virginia-based credit unions will benefit from a collective \$50,000 in grant funds aimed at enhancing financial literacy and empowerment across the Commonwealth.

This initiative marks the first year of a planned five-year program, with \$1 million worth of funding, designed to support projects that promote financial education, reduce dependency on predatory financial services and strengthen community well-being.
