Eugene H. Farley Award of Excellence: Chris Williams



The Eugene H. Farley Award of Excellence is awarded to an individual who has made substantial contributions over a period of two or three years. This year's recipient, Chris Williams, CEO of Henrico Federal Credit Union, has exemplified exceptional leadership and dedication to advancing the credit union mission on a local, state, and national level.

Williams has led Henrico Federal Credit Union through numerous strategic initiatives that have substantially improved operational efficiency and member services.
