Florida Credit Union Association Honors Florida Congressman Byron Donalds as 2024 Federal Lawmaker of the Year

He was formally honored last week at the America's Credit Unions Governmental Affairs Conference in Washington, D.C.

"Thank you to the dozens of credit union officials from across the Sunshine State who joined us in our nation's capital last week," expressed Congressman Byron Donalds, Member of the House Financial Services Committee. "I am honored to be named as the 2024 Federal Lawmaker of the Year."
